78.53% owned by the US corporation Sky Global Holdings, Inc., itself a subsidiary of The News Corporation Limited (an Australian corporation), and 21.47% owned though shares traded on NASDAQ and NASDAQ-Europe. Both Sky Global Holdings, Inc. and The News Corporation Limited have their principal U.S. offices in New York, New York. The world headquarters of NDS is in Middlesex, England. NDS has offices throughout the world, with its largest office in Jerusalem, Israel.

- 4. NDS does not maintain offices in the United States. NDS Americas's primary office is in Newport Beach, California. NDS Americas also has offices in New York, New York, Lake Forest, California (which is between Los Angeles and San Diego), and Miami Lakes, Florida.
- 5. Specifically, NDS does not have an office in northern California. I understand that the U.S. District Court for the Northern District of California covers Alameda, Contra Costa, Del Norte, Humboldt, Lake Marin, Mendocino, Monterey, Napa, San Benito, Santa Clara, Santa Cruz, San Francisco, San Mateo, and Sonoma counties. NDS does not have an office within the Northern District of California, and it has no employees, officers or directors who work in the Northern District of California. Moreover, NDS owns no real property in the Northern District of California, and it has no telephone listings or mailing addresses in the Northern District of California. Additionally, it does not maintain a bank account in the Northern District of California.
- 6. NDS does not conduct board of directors or shareholder meetings in the Northern District of California. Board meetings are normally held in New York, New York. NDS's registered address for the service of process is One London Road, Staines, Middlesex, England TW18 4EX. NDS's agent for service of process in United States is Arthur Siskind c/o The News Corporation Limited at 1211 Avenue of the Americas, New York, New York.
- 7. NDS has no clients in the United States, and all its operations and marketing in the US are conducted through NDS Americas. None of NDS's clients are based in the Northern District of California. NDS pays no franchise or corporate taxes for revenues or

1	activities that occur within the Northern District of California. NDS has not contracted		
2	with persons residing in the Northern District of California to act on its behalf with		
3	respect to marketing, distributing, or servicing any of its products or services.		
4	8. Canal+ has identified several NDS and NDS Americas employees with		
5	knowledge of the alleged facts in this case. Except for two individuals working for NDS

8	9. NDS maintains no company records in the Northern District of California.		
9	To the extent that it has documentary evidence that bear on the allegations of Canal+'s
