4 IS HEREBY ORDERED THAT:

6 Pilon, Henri Kudelski, Joel Conus, Alan Guggenheim, and Suzanne Guggenheim  
7 are ordered to appear live to give testimony for trial in Santa Ana, California  
8 beginning April 9, 2008 until completion of trial, or until such date that the Court  
9 dismisses Ms. Guggenheim and Messrs. James, Ereiser, Dionisi, Saggiori, Pilon,  
10 Kudelski, Conus, and Guggenheim.

11 (2) Graham James, Ronald Ereiser, Anthony Dionisi, Jan Saggiori,  
12 Laurent Pilon, Henri Kudelski, and Joel Conus are to be permitted to enter into the  
13 United States for purposes of providing necessary trial testimony in this matter.
