1 On April 18, 2007, during the deposition of Plaintiff NagraStar's corporate
2 representative, NagraStar testified that it had received certain NDS-related emails from a
3 confidential source in Canada in or around January of 2005 or 2006. NagraStar objected
4 to identifying the confidential source of the documents absent a court order. On April 23,
5 2007, the parties appeared before this Court and Defendants requested that the Court issue
6 an order compelling Plaintiffs to disclose the identity of the confidential source. Plaintiffs
7 opposed defendants' request.

8 After consideration of the parties' argument and the facts presented, IT IS
9 HEREBY ORDERED that:

- 10 1. The request is GRANTED.
- 11 2. Plaintiffs shall disclose in writing within 2 days of notice of the signing
12 of this order the identity and any known contact information for the confidential source
13 who NagraStar referenced as providing the subject documents to NagraStar.
