(RE: DEFENDANT JAN SAGGIORI)

The Court, having read and considered the within duly executed Consent Judgment  
by Defendant Jan Saggiori, and good cause appearing therefor, hereby

ORDERS that the Permanent Injunction shall be and is hereby entered, as follows:

1. Defendant Jan Saggiori, and any persons or entities controlled directly or indirectly by  
him, are hereby permanently enjoined and restrained from:

(a) receiving or assisting others in receiving DIRECTV's satellite transmissions of  
television programming without authorization by and payment to DIRECTV;

(b) designing, manufacturing, assembling, modifying, importing, exporting, possessing, distributing or selling counterfeit DIRECTV Access Cards or other devices or equipment (including, by way of example, software, deglitchers, unloopers, un99 machines and programmers) designed or intended to facilitate the reception and decryption of DIRECTV's satellite transmissions of television programming by persons not authorized to receive such programming;

(c) advertising the sale of counterfeit DIRECTV Access Cards or other devices or equipment (including, by way of example, software, deglitchers, unloopers, un99 machines and programmers) designed or intended to facilitate the reception and decryption of DIRECTV's satellite transmissions of television programming by persons not authorized to receive such programming, and advertising or providing information or technical services in support thereof; or

(d) reverse engineering or attempting to reverse engineer any of Plaintiffs' products, services or technologies, including without limitation the encryption and security controls for the DIRECTV satellite system.

2. This Permanent Injunction shall apply to Defendant Jan Saggiori's activities worldwide, and shall apply with the same force and effect to the DIRECTV Latin America (also known as Galaxy Latin America) and Sky Latin America satellite systems, and to any other direct broadcast system or other business in which Plaintiffs have a financial or other interest, now or in the future.

3. Defendant Jan Saggiori, and any persons or entities controlled directly or indirectly by him, are hereby permanently enjoined and restrained from:


(a) investing or holding any financial interest in any enterprise which Defendant Saggiori knows is now, or planning in the future, to engage in any of the activities prohibited by this Permanent Injunction; or

(b) knowingly allowing any persons or entities which he controls, either directly or indirectly, to engage in any of the activities prohibited by this Permanent Injunction.

4. In the event that Defendant Jan Saggiore becomes aware that an enterprise in which he has invested or holds any financial interest is engaged in any of the activities prohibited by this Permanent Injunction, he agrees to immediately divest himself of any such investment or financial interest and to promptly notify Plaintiffs of the same. "Indirect control" shall mean the ability to compel the person or entity to choose one course of action over another.



5. The Court shall retain jurisdiction to entertain such further proceedings and to enter such further orders as may be necessary or appropriate to implement and/or enforce the provisions of this Permanent Injunction. Defendant Jan Saggiore specifically consents to personal jurisdiction and venue in the United States District Court, District of Montana.




The Court having entered the Permanent Injunction, plaintiffs hereby dismiss all claims against
