Chris Tarnovsky was a co-signatory on a Morgan Stanley brokerage account (187-31472-022) that is now closed. The other signatory was Sylvie Berny (the maiden name of Tarnovsky's wife).

# IV. Site Survey

A site survey was conducted on Chris Tarnovsky's residence in Vista, CA, approximately ten miles east of Oceanside, CA. in San Diego's 'North County'. As noted in the report on Chris Tarnovsky, the subject and his wife purchased the residence at 2339 Carioca Place on 28 June 2002 for \$592,500.00. The home has four bedrooms with three and a half bathrooms, library and a four-car (tandem) garage. The neighborhood is referred to as Somerset Glen and is in east Vista. At this time Carioca Place is a cul-de-sac with only four homes. When another phase of development is completed, Carioca will be cut through. At present, the subject's residence has only one road entrance and would be easy to surveil.

#### VI. Recent Travel

## A. Dayton, OH

CGT attended the HAMVENTION, a HAM radio operators convention, in Dayton, OH from 15 May 2002 to 19 May 2002. (The website, <a href="https://www.hamvention.org">www.hamvention.org</a>, describes this as the "world's largest amateur radio gathering and trade show" held at Dayton's Hara Arena Complex).

**Note:** George Tarnovsky and another male were also there. Sources report that George Tarnovsky stays at this hotel approximately four times per year.

While he was there, CGT stayed at the Residence Inn Dayton North in the Penthouse Suite. He made several long distance calls and sent several local faxes. One of the long distance calls is linked to a Scott Davis (see below).

While in Dayton, CGT also used the Mailboxes, Etc. at 1209 Dayton Yellow Spring Road (approx. 17 miles away in Fairlawn, OH) to ship several packages to himself at his home address (then 737 Poppy Road). One of the packages is described as weighing 41 pounds. Another is described as weighing 68 pounds, with a declared value of either \$200 or \$900 (not discernable). The charges for these shipments came to \$123.26 and \$220.01.

#### B. Additional Travel

There is reason to believe that Chris Tarnovsky has travelled in the following manner:

- 11-12 July France and Belgium
- 14-17 July Israel
- 20 July Belgium
- 30 August New Jersey

#### VII. Connection to Texas

According to media coverage and the client, Chris Tarnovsky was identified as the ultimate recipient of packages sent from Canada (and elsewhere, including Eric Kuhn) to

a San Marcos, TX Mailboxes, Etc. As a result, a search was conducted to identify other links between him and Texas. Searches determined that Christopher Tarnovsky received a vehicle citation on 27 July 2000 in Texas.

Additionally, on 16 August 2000, Chris and Sylvie Tarnovsky sold a 1996 Pontiac to Lois E. Bingham, who lives in Luling, TX – not far from San Marcos, TX. A search of information related to Lois E. Bingham indicates that she has been linked to the alias "Lois Tarnovsky."

Other Tarnovsky-related individuals linked to her 1801 Washburn Road, Luling, TX residence include Andrew V. Tarnovsky (born 30 November 1977) and Nikolai A. Tarnovski (born 12 January 1976). Searches also determined that Lois E. Bingham and Richard Bingham are both linked to the same New York address that George Tarnovsky is linked to – 95 Prospect Avenue, Maybrook, NY 12543. Chris E. Bingham (born 1966) is also linked to the TX and NY addresses.

**Note:** A separate search related to George and Evelyn Tarnovsky confirms that they are related to Lois Bingham.

### VIII. Purchase of Technical Equipment

#### A. Bid-Service, LLC

It has been confirmed that Chris Tarnovsky has purchased high-tech equipment related to the semiconductor industry from a New Jersey-based company named Bid-Service, LLC. The website for this company (www.bid-service.com) identifies it as "The oldest, largest and most respected dealer of used and refurbished semiconductor processing, microscopes, laboratory, electronic test and measurement, and general scientific equipment in the world!" We have obtained copies of invoices showing the following purchases:

9 January 2002

K&S Probe (4524), \$18,500. This invoice has the name "John Norris" under the "purchasing" field and the products were shipped to Chris Tarnovsky via Atlas Van Lines.
